Continuing Education hours are required annually.

Council will accept CE hours from 1st October of the prior year that have not been previously submitted.

Sixty (60) percent of CE must be SPECIFIC to the practitioner's discipline and must be provided from an accredited institution representing that discipline alone. Medscape cannot be used for the 60% specific hours.

The 40% can be in an area of General Medicine Related Topics (of which 20% only can come from Medscape). Approving the suitability of training as CE is subject to the Council's discretion.

The original CE Certificates must be provided. Copies should be provided if the practitioner wishes to have the originals returned.

The Council encourages the practitioners to exceed the minimum requirements on an annual basis. Therefore, CEs obtained beyond and above the minimum hours required for registration cannot be carried over for use in the following year's registration.
