## Application for Registration of a Charitable Organisation

in accordance with the Cayman Islands Labour Act (2021 Revision)

Definition of a Charitable Organisation as per the Labour Act - An organisaiton accepted and registered as such by the Director.

## The Cayman Islands Labour Act (2021 Revision) does not apply to:

- The Public Service: Provided that the Personnel Regulations, 2006, from time to time applying to the public service shall not prescribe or permit conditions of service which are less favourable to the employee than those required by this Act;
- · Charitable Organisations; or
- Churches

**Note:** Upon approval, a Certificate of Registration signed by the Director of Labour & Pensions will be issued to each registered Charitale Organisation. This certificate is valid for twenty four (24) months and expires on the anniversary date of the registration. Thereafter, a renewal application is required for consideration of continued exemption.
